The Cottonelle® Refreshingly Clean Slate Sweepstakes ("Sweepstakes") is sponsored by Kimberly-Clark Corporation ("Sponsor"), 2100 Winchester Road, Neenah, WI 54956, and is administered by Prize Logic, LLC ("Administrator"), 25200 Telegraph Road, Suite 405, Southfield, MI 48033, USA.

1. **SWEEPSTAKES TIMING:** The Sweepstakes begins on December 11, 2020 at 12:00 PM (noon) Eastern Time ("ET") and ends on December 31, 2020 at 11:59:59 PM ET ("Sweepstakes Period"). The Administrator's computer is the Sweepstakes' official clock.
2. **ELIGIBILITY:** The Sweepstakes is offered only to legal residents of the fifty (50) United States, the District of Columbia and who are at least twenty-one (21) years of age at the time of entry. Employees, officers, directors, representatives, and agents of Sponsor, Administrator, Ketchum, Mindshare, Digitas and each of their respective parent companies, subsidiaries, affiliates, advertising and Sweepstakes agencies, (collectively, "Sweepstakes Entities") and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All applicable federal, state, provincial, territorial, and local laws and regulations apply. Void where prohibited or restricted by law. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor and Administrator's decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein. All entries become the sole and exclusive property of the Sponsor and receipt of entries will not be acknowledged or returned.
3. **HOW TO ENTER THE SWEEPSTAKES:** During the Sweepstakes Period, an eligible entrant ("Entrant") must take a picture what they would like to flush out about the year 2020 on a piece of toilet paper ("Photo"). The Entrant may enter the Sweepstakes by using the following two (2) methods below:
 - A. **Instagram:** To enter on Instagram, an Entrant must (i) log on to his/her Instagram account, (ii) follow @cottonelle (if he/she does not already do so), and (iii) post the Photo along with the hashtags #RefreshinglyCleanSlate #Sweepstakes (the "Sweepstakes Hashtags") and (iv) state what he/she is looking forward to in 2021 on the posting to receive one (1) entry into the Sweepstakes ("Instagram Entry"). An Instagram Entry must be a Photo taken and posted during the Sweepstakes Period. An Entrant may not add a Sweepstakes Hashtags to an image posted prior to or after the Sweepstakes to obtain an entry into the Sweepstakes.

An Entrant must follow @cottonelle and have a non-private Instagram account to enter the Sweepstakes and maintain such non-private account for at least sixty (60) days after the Sweepstakes Period ends to be eligible to win/claim a prize for potential winner notification purposes. Due to the way Instagram operates its service, Sponsor may not receive Instagram Entries from

Instagram users with “protected” updates/private post (i.e., an Entrant has set his/her account so that only people the Entrant has approved can view his/her updates).

To participate in the Sweepstakes via Instagram, an eligible Entrant must already have or create a non-protected Instagram account. B. Twitter: To enter on Twitter, an Entrant must (i) log on to his/her Twitter account, (ii) follow @cottonelle (if he/she does not already do so), and (iii) Tweet the Photo including the Sweepstakes Hashtags and (iv) state what he/she is looking forward to in 2021 on the posting to receive one (1) entry into the Sweepstakes (“Twitter Entry”). A Twitter Entry must include an image in the Tweet – an Entrant may not Tweet a link to an image posted on a 3rd party site to obtain an entry into the Sweepstakes.

To participate on Twitter, an Entrant must have a non-protected Twitter account. Due to the way Twitter operates its service, Sponsor may not receive Twitter Entries from Twitter users with “protected” updates (i.e., an Entrant has set his/her account so that only people the Entrant has approved can view his/her updates).

In addition, by submitting an Entry, each Entrant agrees that his or her entry conforms to the entry guidelines and restrictions set forth below (“Entry Guidelines and Restrictions”). Each Entrant hereby understands and agrees that, at Sponsor’s sole discretion, his/her Entry may be posted to the Sponsor’s website, any of Sponsor’s social media properties and/or websites, and/or other websites or social media accounts associated with the Sweepstakes. Submitting an Entry constitutes Entrant’s grant to Sponsor, its parents and affiliates, and the employees, officers, directors, licensees, designees, agents, successors and assigns (collectively, “Grantees”), of a royalty-free, irrevocable, perpetual, nonexclusive license to use, reproduce, modify, post, distribute, publish or create derivative works from and display the Entry in whole or in part, on a worldwide basis, and to incorporate it into other works, in any form, media or technology now known or later developed, including for promotional, advertising, public relations, trade show and/or marketing purposes, without further compensation, notification or permissions of any kind except where prohibited by law. requested, Entrant will sign any documentation that may be required for Sponsor or its designees to make use of the nonexclusive rights Entrant is granting to use the Entry. This license expressly includes a right (but not the obligation) for Sponsor to modify Entries to remove any third-party intellectual property. Sponsor shall have the right, in its sole discretion, to edit, composite, morph, scan, duplicate, or alter the Entry for any purpose which Sponsor deems necessary or desirable, and each Entrant irrevocably waives any and all so-called moral rights they may have therein. Each Entrant hereby acknowledges that such Entrant does not reserve any rights in or to the Entry. The displaying of an Entry on any website/social media platform does not constitute verification of eligibility or compliance with these Official Rules and all Entries and Entrants remain subject to verification of eligibility and compliance with these Official Rules as determined by Sponsor at its sole discretion.

Entrants agree that Sponsor has the right, but not the obligation, to use and/or otherwise display the Entries as set forth above, and that if such Entries are, in Sponsor's sole discretion, displayed on any website/social media platform, such Entries may be subject to third party comments that will be publicly viewable, and further, such Entries may also be saved, shared, and/or further e-mailed by such third parties on the internet or otherwise.

Limit one (1) Entry per Entrant per social media platform during the entire Sweepstakes Period.

In the event of a dispute as to any Entrant for purposes of the Sweepstakes, the Authorized Account Holder of the e-mail address associated with the social media account used to make the Entry will be deemed the Entrant. "Authorized Account Holder" is defined as the natural person who is assigned to the e-mail address by an Internet Access Provider, Online Service Provider or other organization (business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the e-mail address associated with the social media account used to enter the Sweepstakes. 6. **RANDOM DRAWING:** On or about January 4, 2021, Administrator will select twenty (20) potential winners from among all eligible entries received during the Sweepstakes Period. The winner is deemed to be a potential winner, pending verification of the entrant's eligibility and compliance with these Official Rules as determined by Sponsor or Administrator, at their sole and absolute discretion.

7. PRIZE, APPROXIMATE RETAIL VALUE (“ARV”), AND ODDS OF WINNING:

A. Prizes (20): Each “Prize” is Twenty-One Thousand Dollars (\$21,000) fulfilled via Chase QuickPay®. The ARV of all Prizes is Four Hundred Twenty Thousand Dollars (\$420,000). No more than twenty (20) Prizes will be awarded in the Sweepstakes.

B. Odds of Winning/Limit: The odds of winning a Prize depend on the number of eligible entries received during the Sweepstakes Period. There is a limit of one (1) Prize per Entrant.

8. HOW TO CLAIM A PRIZE: Potential winners who entered via Instagram will be notified at his/her Instagram account via a Direct Message from @cottonelle with instructions on how to claim his/her Prize. Potential winners who entered via Twitter will be notified at his/her Twitter account via a Direct Message from @cottonelle with instructions on how to claim his/her Prize. Before being declared the winner, the potential winner will be required to execute an Affidavit of Eligibility/Liability & Publicity Release and tax acknowledgment (“Affidavit”), sent with the e-mail notification. The potential winner must return a fully executed and notarized Affidavit to the Sponsor or its authorized designee within ten (10) calendar days from the date it is postmarked as being sent to the potential winner or the Prize may (in Sponsor’s sole discretion) be forfeited. Each potential winner may be subject to a background check before the Prize is awarded. Sponsor reserves the right to disqualify the potential winner based on the results of such background check if Sponsor determines in its sole discretion that awarding the Prize to any such individual might reflect negatively on the Sponsor. Sponsor will attempt to award a Prize approximately 6 – 8 weeks from verification of winner’s eligibility. Sweepstakes Entities shall not be held responsible for any delays in awarding a Prize for any reason.

THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN MICHIGAN. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN OAKLAND COUNTY, MICHIGAN. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR SWEEPSTAKES ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION.
